



Notification of The Institute for the Promotion of Teaching Science and Technology
On Intention of Administration with Good Governance

As a government agency that has continuously committed to the prevention and suppression of corruption in the organization, The Institute for the Promotion of Teaching Science and Technology (IPST) hereby notifies its intention of administration with honesty, good governance, morality, transparency and cooperation from all sectors to prevent and suppress the corruption and misconduct by focusing on public interests, creating the administration system with transparency, efficiency, and morality and encouraging the general public to take part in the deterrence of corruption and misconduct of government officials, which would lead to the shared values of anti-corruption at the national level. IPST's intention of administration with honesty includes the following practices:

1. **Transparency:** all IPST units perform duties by allowing disclosure of information on all activities, access to administration and procurement information, and participation from all stakeholders in order to improve the execution capability for effectiveness, transparency, and equality.

2. **Accountability:** IPST performs its duties and administration with good governance and determination and upholds the rule of law and regulations by considering the benefits to the public, clients, and stakeholders and taking responsibilities for the consequences of any actions with honesty.

3. **Anti-corruption:** IPST promotes the administration with morality that is free from policy corruption and malpractice. IPST personnel shall not use position or bribe to gain any personal advantages. IPST executes its mission with fairness, transparency, and adheres to the service standards, administration methods, and work manuals without discrimination.

4. **Organizational Ethical Culture:** IPST creates an anti-corruption plan, executes preventive measures for corruption and conflicts of interest, and follows up on the execution to build and maintain a culture of honesty.

5. **Work morality in Organization:** IPST specifies ethical standard, instills moral values into government personnel, focuses on public interest, develops merit and transparent system for the administration, human resource management, budgetary management, and assignation, improves workplace efficiency, and applies the Sufficiency Economy Philosophy to work duties and daily lives.

IPST president, executives, personnel, and their family members shall not request any gifts or benefits from any clients, parties, colleagues, employees or subordinates under any circumstances.
